Attach statements indicating tax received and remitted for each category and, for a bulk sale, items on which tax was not collected. Mail your Certificate of Authority and the final return to the appropriate address listed on the back of the sales tax return.

Change of Business Information—Use Form DTF-95, Change of Business Information, to report a change of legal name or trade (dba) name, business or mailing address, officers' information or to change a Tax Department assigned ID number to a federal employer identification number (EIN).
